- However, please do notify us if you move address or your child stops living with you.
- If this claim is unsuccessful but your circumstances later change to meet the above criteria, please re-apply.
- This application is only valid for the child/children listed overleaf. If you meet the qualifying conditions listed above, a new application form will be required for the following circumstances:
  - For further children reaching school age (Reception)
  - If your child/children move to a Dudley MBC school from another Local Authority
  - For further children who join your household
